

DIVORCE DEED

This Divorce Deed is made at Karachi, on this 24th day of January 2019.

KNOW ALL MEN BY THESE PRESENTS that I, XXXXXS/O 00000, Muslim, Adult, Resident of House No. C - 3333, Near Khizra Masjid Tihnatti No. 2, Karachi 44. Holding CNIC No.4000-8251725-3 do hereby declare and state as under:

1. That I am executing this Deed for pronouncement of divorce to my wife namely **AAAAA D/O 000000** for written record in all concerned authorities.

2. That I am the Executant of this Divorce Deed and fully conversant with the facts mentioned below and have executed without any duress, coercion and compulsion, fully appreciating and understanding the import and consequences hereof.
3. That I was married with **Mst. AAAAA D/O OOOOOO**, Muslim, adult, R/O House No. B-OOO, PECHS, Karachi in accordance with the Muslim Sunni Law on 12-11-2010 against the dower amount RS. 50,000/= and from the said wedlock three issues were born namely:
 - (i) OOO (Son) Age 9 years
 - (ii) OOO (Son) 7 years
 - (iii) OOO (Daughter) 1 year
4. That under the circumstances mentioned herein below, with my own consent do hereby execute this Deed of Divorce here at Karachi.
5. That from very beginning of the marriage I tried my level best to keep **Mst. AAAAA D/O OOOOOO**, happy and I fulfilled my all matrimonial obligations towards her as such due to differences in mind thoughts between us/spouses I tried my best to incline her and myself but could not get through.
6. That **Mst. AAAAA D/O OOOOOO** is disobedient, aggressive, stubborn and disrespectful wife. Due to her behavior and other matrimonial disputes which she creates unnecessary I could not continue this relationship anymore from now onwards. In view of above circumstances I reached at the conclusion that there is no possibility to live with her as husband and wife in accordance with the prescribed limits of Al-Mighty Allah and it will be futile to continue this marital relationship in future.

7. That despite of all sincere efforts, love, affections and kind behavior **Mst. AAAAA D/O OOOOOO** neither changed herself nor did she realize her matrimonial responsibilities while on the contrary her conducts and attitude became bad to worst.
8. That **Mst. AAAAA D/O OOOOOO** may remove all her belongings, wearing apparel, Jewellery, furniture, electronic items and other personnel from my place and retain as her personal property.
9. That I have paid the Dowry amount of Rs. 50,000/- (Rupees Fifty Thousand Only) according to the Nikkahnama's point No. 13.
10. That I am ready and willing to give the divorce to **Mst. AAAAA D/O OOOOOO** by pronouncing Three Times Divorce in presence of witnesses as under:
 - I. I, XXXXXS/O OOOOO do hereby pronounce Talaq/Divorce to my wife **Mst. AAAAA D/O OOOOOO**.
 - II. I, XXXXXS/O OOOOO do hereby pronounce Talaq/Divorce to my wife **Mst. AAAAA D/O OOOOOO**
 - III. I, XXXXXS/O OOOOO do hereby pronounce Talaq/Divorce to my wife **Mst. AAAAA D/O OOOOOO**.

Now, the above said **Mst. AAAAA D/O OOOOOO** Is totally free from my side, stands under no obligation to me and I have no concern with her as wife and after the expiry of "Iddat" Period she will be at liberty and it will be lawful for her to contract second marriage with any other person, as per her choice if she desires so.

Whatever is stated is above in Divorce Deed is true and correct to the best of my knowledge and belief
